# **Benefits**

The monthly amount of the grant is 1 144,64 € (one thousand one hundred and forty four euros and sixty four cents), as per FCT's stipends values in force (https://www.fct.pt/apoios/bolsas/docs/Tabela\_Valores\_SMM\_LOE\_2021.pdf), paid monthly, in accordance with the P.PORTO Research Grant Regulations, and is foreseen in the respective Request for Expenditure (PAD) n.º ISCAP4734.

- b) not exceed, with the conclusion of the grant contract in question, an accumulated period of two years in this type of grant, be that consecutive or interpolated.
- If the applicant is a Ph.D. student: the applicant must hold a master's degree and be enrolled in a PhD programme on the date the grant is contracted. Specific Requirements:
- Academic background in administrative assistance, communication or a related area.

# Selection process

The selection methods to be used are:

- a) Curricular assessment, weighting 50%;
- b) Interview, weighting 50%, which will be applied to the six candidates ranking first in the Curricular assessment, in descending order of classification. The respective evaluation parameters are:
- a) In Curriculum assessment:
- o Final average of the required master's degree (between 10 and 12 values 2 points; between 13 and 15 values 4 points; between 16 and 20 values 10 points);
- o Publication of articles, communications and scientific publications (up to 10 points).
- b) Interview: the interview aims to assess professional/academic experience and behavioural aspects, namely those related to motivation and willingness to perform the required duties, fluency (oral and written) in Portuguese and English, results orientation, planning and organisation, problem solving skills, and orientation towards using information and communication technologies. This method is assessed according to the classification levels of High, Good, Sufficient, Poor and Insufficient, to which correspond, respectively, the classifications of 20, 16, 12, 8 and 4 values. The final result (RF of the Interview) is obtained through the simple arithmetic mean of the marks of the parameters to be evaluated:

RF of Interview = (MD+EP/A+RP+TIC+C+CI) /6, where:

- MD = Motivation and availability for the performance of duties;
- EP/A = Professional/Academic Experience;
- RP = Ability to solve problems;
- TIC = Orientation towards the use of information and communication technologies.
- C = Communication;
- CI = Communication in English.

Applicants are excluded from the competition on the following grounds:

- a) For not holding the general and specific requirements referred to in point 2;
- b) Applicants who obtain less than 9,5 points in the Interview;
- c) Failure to attend the Interview.

After the analysis of the applications and the evaluation of the applicants according to the components concerned, the applicants will be ranked in descending order of scores. In the case of a tie, the tie-breaker will be based on the best classification, in the following order of presentation:

- a) Interview;
- b) Curriculum assessment.

If a tie remains, the Selection Board will proceed to a vote where all elements of the Board shall vote, being the President of the Board responsible for the quality vote in case of new tie.
