Item 1 – Assessment of the relative merit of the admitted candidates;

In accordance with Point 15 of the [Public Notice](#) of the Call for Applications, the Selection Committee evaluated the submitted application for the purpose of assessing relative merit, taking into consideration the evaluation criteria and parameters, as well as the weighting factors set out in the aforementioned Notice. Accordingly, the Committee:

based on the scoring grids provided by each member of the Selection Committee, which are annexed to this Record, held a vote to reach an absolute majority in the final ranking of the candidate, as presented in the table below:

It was decided not to grant a hearing of the interested party, considering that the decision is entirely favorable to the candidate, in accordance with Article 124(f) of the Code of Administrative Procedure, approved as an annex to Decree-Law No. 4/2015 of January 7;

Item 2 – Ratification and disclosure of the final definitive ranking list of the candidate

The Committee also resolved that the provisional final ranking list shall now be deemed the definitive final ranking list. Therefore, the entire process may be submitted to the President of ISCAP for the purpose of ratifying the final ranking list.

(EN) Evaluation of the candidate Adalberto Fernandes

I have carefully reviewed the application submitted by Adalberto Fernandes, including the curriculum vitae, selected scientific publications, project and activity plan, and supporting documentation, in the context of the international tender for the position of Assistant Researcher at the Centre for Organisational and Social Studies of the Polytechnic of Porto (CEOS.PP), in the scientific area of Media and Communications, with an emphasis on the intersection of communication and technology.

In accordance with the procedures set forth in the public notice and the criteria defined by the selection panel, I began by assessing the candidate's absolute merit. Based on the relevance, quality, and timeliness of the candidate's academic trajectory and scientific contributions—particularly the five selected works—I find that the candidate does meet the minimum standards expected for the performance of duties as an Assistant Researcher in the field in question.

Having established his approval on absolute merit, I proceeded to evaluate the candidate according to the weighted criteria defined in the notice. Regarding **scientific and technical merit** (65%), the candidate has demonstrated a good publication record in indexed journals, active participation in funded projects, good knowledge of funding opportunities and significant recognition by the scientific community (eg. As a reviewer in several journals, member of associations and of editorial boards). The proposed three-year scientific and activity plan reflects a well-structured, methodologically sound project with potential for high impact.

In the area of **service to the community and knowledge transfer** (10%), I note some engagement with non-academic audiences (eg. Associations, municipalities, arts).

Concerning **experience and professional qualifications** (10%), the candidate presents suitable academic degrees and qualifications and a solid previous experience in research roles, even if not specifically in the required field of studies.

In terms of **supervision and training** (10%), he does not show evidence of previous experience in supervision, but does have some training records (eg. Travel grant in Croatia).

Lastly, in the criterion of **institutional and scientific management activities** (5%), the candidate has no explicit records.

Taking into account all the elements reviewed, I recognize the overall merit demonstrated across the various dimensions of evaluation and the candidate's potential to contribute significantly to CEOS.PP's mission in the field of Media and Communication.

(PT) Avaliação do candidato Adalberto Fernandes

Analisei cuidadosamente a candidatura apresentada por **Adalberto Fernandes**, incluindo o *curriculum vitae*, as publicações científicas selecionadas, o Plano de atividades e projeto científico, bem como a documentação de suporte, no âmbito do concurso internacional para o lugar de **Investigador Auxiliar** no Centro de Estudos Organizacionais

e Sociais do Politécnico do Porto (CEOS.PP), na área científica de **Media e Comunicação**, com ênfase na interseção entre comunicação e tecnologia.

De acordo com os procedimentos definidos no aviso de abertura e com os critérios estabelecidos pelo júri de seleção, iniciei a avaliação pela **verificação do mérito absoluto** do candidato. Com base na relevância, qualidade e atualidade do percurso académico e das contribuições científicas apresentadas—em particular dos cinco trabalhos destacados—considero que o candidato **cumpre os requisitos mínimos exigidos** para o desempenho das funções de Investigador Auxiliar na área científica em causa.

Estabelecido o seu mérito absoluto, procedi à avaliação do candidato segundo os critérios ponderados definidos no aviso. No que se refere ao **mérito científico e técnico** (65%), o candidato demonstrou um bom histórico de publicações em revistas indexadas, participação ativa em projetos financiados, bom conhecimento de oportunidades de financiamento e reconhecimento relevante pela comunidade científica (por exemplo, como revisor em várias revistas, membro de associações e de conselhos editoriais). O Plano trienal de atividades e projeto científico apresentado revela-se bem estruturado, metodologicamente sólido e com potencial de elevado impacto.

Na componente de **prestação de serviços à comunidade e transferência de conhecimento** (10%), regista-se algum envolvimento com públicos não académicos, nomeadamente associações, municípios e setor artístico.

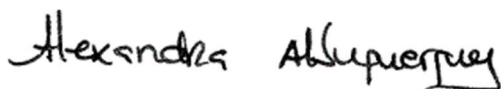
Relativamente à **experiência e qualificações profissionais** (10%), o candidato possui títulos académicos e qualificações adequadas, bem como experiência sólida em funções de investigação, ainda que não especificamente na área científica exigida pelo concurso.

No que respeita à **supervisão e formação** (10%), não apresenta evidências de experiência anterior em supervisão, embora constem alguns registos de formação (por exemplo, uma bolsa de mobilidade na Croácia).

Por fim, no critério de **atividades de gestão científica e institucional** (5%), não foram indicados registos explícitos por parte do candidato.

Tendo em consideração todos os elementos analisados, reconheço o mérito global demonstrado nas várias dimensões de avaliação, bem como o potencial do candidato para contribuir de forma significativa para a missão do CEOS.PP no domínio do concurso em questão.

Dr. Fernandes's profile indicates a strong capacity to contribute to interdisciplinary projects and enhance the institution's strategic goals. His experience in teaching and supervising at the Master's and Doctoral levels and his involvement in organizing academic events and reviewing several journals further underscore his commitment to the academic community. His language proficiency, including proficiency in English and Portuguese, and intermediate to upper-intermediate skills in Spanish and French, will also be an asset.

Justification for the Consideration of the Candidate Adalberto Fernandes

After careful review of Adalberto Fernandes' application for the tenure-track position in Media and Communication, I find that the applicant has great merit and shows very strong potential.

Fernandes has a PhD in Philosophy (2023), an MA in Communication (2014), an MA in Bio-Ethics (2013), and a BA in Communication (2010) and is therefore well-qualified to fill the position. His publications – many of them appearing in very good international journals or in books by highly respected publishers – display a sophisticated understanding of the ways in which media and communication intersect. He has a particular interest in science and health communication (concerning the COVID 19-pandemic, right-wing populism, etc.). Additional areas of expertise include journalism, trust and risk studies, political communication, biopolitics and bioethics. His methodologies include critical discourse analysis and visual analysis. He is, overall, a well-rounded scholar working on significant current concerns.

Fernandes is a researcher at CinTurs - Research Center for Tourism, Sustainability and Well-being (University of Algarve) and a collaborator at the Institute of Contemporary History (NOVA University Lisbon) in the FCT-funded ProjectCEMA. As such, he is involved in significant research contexts and initiatives.

His substantial high-quality publication output, research engagement, and additional experience as a frequent reviewer for several journals indicate that he is not only a very active but also a nationally and internationally well-connected and respected scholar. His publications and conference presentations further indicate his ability to work in interdisciplinary contexts.

I fully support the committee's decision to offer Adalberto Fernandes the advertised position. I scored his application with the mark of 66,1 (slightly above his final score of 62,15), finding him particularly strong in his publications and his recognition by the international scientific community, as well as his overall fit for the advertised profile.
