On the above-mentioned date and at the time, the Jury of this tender procedure met to deliberate on the single item on the agenda, using the powers provided by the Rules for Employment of Teaching Staff of the Polytechnic University of Porto (IPP Competitions Regulations), published by Order no. 4807/2011, in the Official Gazette, Series 2, no. 54, of 17 March, and in accordance with the provisions of the Tender Notice (Competition Notice), with reference ISCAP-17/2023 and published in the 2nd Series of the "Diário da República" no. 128, of 04 July 2023 by Notice (extract) no. 1148/2023, and on ISCAP's website at www.iscap.ipp.pt (https://www.iscap.ipp.pt/documentos-publicos/procedimentos-concursais/a-decorrer/a-decorrer). The meeting was chaired by ISCAP's Secretary Pedro Miguel da Costa Soares.

## Single item: Admission/exclusion of the application(s) under the terms and for the purposes established in item 4 of the Notice and article 17(1) of the Regulations governing Competitions for the Recruitment of Teaching Staff at the Polytechnic Institute of Porto.

Pursuant to point 4 of the <u>Notice of Competition</u> and in accordance with the provisions of article 17.1 of the IPP Competition Regulations, the Jury assessed the applications submitted for admission or exclusion on the basis of the conditions laid down for the submission of applications and the requirements for admission to the competition.

The jury unanimously decided to exclude the candidates Astrida Skrinda, Anabela Garcia Ferreira Pinto and Josélia Maria dos Santos José Neves, as they do not hold the "aggregate title or legally equivalent title in the area for which the competition is open", an admission requirement set out in point 4.2 of the <u>Notice of</u> Competition.

The jury unanimously decided to admit the candidate Clara Maria Laranjeira Sarmento e Santos, as she meets all the admission requirements set out in the notice.

- i) to notify the apllicants of the Jury's deliberations so that, if they so wish, they can state their case, under the terms of point 9 of the <u>Tender Notice</u> and articles 121 to 125 of the Code of Administrative Procedure, approved by Decree-Law no. 4/2015, of 7 January;
- ii) to define that this hearing of interested parties must be carried out in writing, duly substantiated and, under penalty of being it rejected outright, must be submitted on the Application Portal: same (https://portal.ipp.pt/concursos/iscap/pessoal/) by accessing the submitted application; the deadline for this hearing is 10 working days, from the working day following the date of the notification email sent via the Application Portal; the decisions will become final in the absence of any allegation within the legal deadline (10 working days, from the working day following the date of the notification email sent via the Application Portal);
- iii) that, as provided in Article 17 of the P.Porto Competitions Regulations, the Jury's deliberations will also be made available on the ISCAP website, at www.iscap.ipp.pt (https://www.iscap.ipp.pt/documentos-publicos/procedimentosconcursais/a-decorrer/a-decorrer), as well as posted at ISCAP's Reception.
